Certification Statements:

1. Competition horses have been within one or more designated countries (Singapore, Japan, the United Arab Emirates, Hong Kong, Ireland, the United Kingdom, France, and the United States) for at least the 60 days prior to export to Korea.
2. Dourine, glanders, African horse sickness, Venezuelan equine encephalomyelitis and equine encephalitis (Eastern and Western) are compulsorily notifiable in the United States.
3. The United States has been free of dourine, glanders, African horse sickness and Venezuelan equine encephalomyelitis for at least 2 years prior to export of competition horses.
4. The competition horses were regularly vaccinated with inactivated vaccine against equine encephalomyelitis (Eastern and Western).
5. Any premises on which the competition horses resided during their stay in the United States or the 60 days prior to export, shall have had no reported cases of strangles, rabies, surra, epizootic lymphangitis, Hendra virus infection, Nipah virus infection, anthrax, equine influenza and vesicular stomatitis for at least 60 days prior to export.
6. The competition horses received a complete primary course of vaccination against West Nile fever and have been regularly re-vaccinated with a vaccine approved by USDA.
7. Any premises on which the competition horses resided during their stay in the United States or the 60 days prior to export shall have had no reported cases of equine viral arteritis for at least 60 days prior to export.
8. Any premises on which the horses resided during their stay in the United States or the 60 days prior to export had no reported cases of equine infectious anemia for at least 60 days prior to export and the competition horses shall be subjected to an agar-gel immunodiffusion (Coggin's) or ELISA test against equine infectious anemia with negative result carried out on a sample taken within 30 days prior to export.
9. Any premises on which the competition horses resided during their stay in the United States or the 60 days prior to export had no reported cases of equine piroplasmiasis (Babesia caballi and Theileria equi) for at least 60 days prior to export and the competition horses were subjected to an indirect fluorescent antibody test or c-ELISA test against equine piroplasmiasis with negative result using a sample taken within 30 days of export.
10. The competition horses shall be examined within 48 hours of export by a USDA or USDA-accredited veterinarian, and be found clinically healthy and free of external parasites and any clinical signs of infectious or contagious disease.
11. The name(s) and address(s) of premises where the competition horses stayed while in the United States and the duration of the stay, as well as the title, date, and place of event which competition horses participate in are attached.
12. I have checked the USDA APHIS IREGS and read in its entirety the protocol for Competition Horses to the Republic of Korea and understand all associated additional requirements, as applicable, have been followed accordingly.
