IV. HEALTH ATTESTATION

I, the undersigned Veterinary Inspector, hereby certify that:

1. Conditions for birth and raising:

The export poultry meat is derived from the poultry, which was born and raised in the exporting country.

2. Conditions for non-outbreak of diseases:
 - (1) There has been no outbreak of notifiable Avian Influenza (NAI)⁽¹⁾ at the area within a radius of 10 km from the poultry farm from which the poultry raised for the production of the heat treated poultry meat was originated during the past 3 months prior to slaughter.
 - (2) There has been no outbreak of Newcastle disease at the area within a radius of 10 km from the poultry farm from which the poultry raised for the production of the export livestock products was originated during the past 3 months prior to slaughter.
 - (3) There has been no outbreak of Fowl cholera, Pullorum, Fowl typhoid, Infectious bursal disease, Marek's disease, Duck virus hepatitis (only for duck meat), Duck virus enteritis (only for duck meat) at the poultry farm from which the poultry raised for the production of the export livestock products was originated during the past 12 months prior to slaughter.
3. Conditions for export establishments:
 - (1) The export establishments are located in areas, which have not been placed under animal health restrictions in connection with any disease mentioned in Article 2.
 - (2) The export establishments did not treat poultry or poultry meat imported from the country from which importation of poultry or poultry meat has been prohibited by the Korean government while the establishment is producing the livestock products for export.
 - (3) The export establishments which produce heat-treated poultry are compartment into a pre-heat treatment facility to deal with raw material and post-heat treatment facility to perform heat treatment and pack products. Workers in those facilities are separated according to the workplace in order to prevent contamination.
4. Conditions of the poultry meat etc.:
 - (1) The poultry meat, etc. is derived from healthy poultry and found suitable for human consumption as a result of ante mortem and post mortem inspection conducted by an official veterinarian of the government of the exporting country at the export establishment.
 - (2) The poultry meat, etc. has been treated in such a way to prevent contamination by livestock epidemic organisms.
 - (3) The residue level of harmful substances such as antibiotics, pesticides, hormones, heavy metals, microbes does not exceed the allowance level (also in accordance with related Korean regulations) under control of the official authorities and not to represent danger for human health.
 - (4) The products have not been treated by food irradiation and ionization, and no food additives (preservatives and meat tenderizers) have been added to the products.
5. The packaging materials for the products are not hazardous to human health. There is a labelling of the export establishment number and an approval mark on the package indicating that the poultry meat was handled in such a way not to cause any trouble to public health. The aforementioned mark is informed to Korean government in advance.
