IV. HEALTH ATTESTATION

I the undersigned, official veterinarian, certify that:

- The pet birds or commercial birds are hatched and raised within the exporting country or have been raised for at least 30 days prior to the export within the exporting country⁽¹⁾;
- There has been no outbreak of High Pathogenic Avian Influenza (HPAI) in the exporting country during the past one year prior to the export of the birds. However, in case the Korean Minister of Agriculture, Food and Rural Affairs recognizes that the efficient stamping-out policy for HPAI has been implemented in the Netherlands, this period may be shortened in accordance with the OIE Terrestrial Animal Health Code;
- The birds which are commercially exported have been isolated and inspected in an embarkation quarantine facility, approved by the government of the exporting country, for at least 21 days prior to shipment, and have been found free from any clinical signs of avian infectious or contagious diseases;
 - Or* 3.2. The pet birds which are non-commercially exported and are accompanied by a traveller, are inspected before export and have been found free from any clinical signs of avian infectious or contagious diseases;
- The birds were transported in new, cleaned and disinfected boxes/containers with an effective disinfectant approved in the Netherlands;
- During transportation within the exporting country and to the Republic of Korea, the birds have not been in contact with any poultry, day-old chicks, birds or their products with lower health status, and have been transported in such a manner to prevent contamination by any pathogens of avian infectious or contagious diseases. The birds have not passed through areas from which poultry etc. is not allowed to import into Korea.
