IV. HEALTH ATTESTATION

The undersigned official veterinarian hereby certifies that:

- 1 For collagen and gelatine derived from bones of cattle from countries with a reported case of BSE⁽¹⁾⁽²⁾
 - 1.1 Collagen and gelatine have been manufactured in such a manner that prevents contamination by any pathogens of infectious animal diseases;
 - 1.2 The cattle from which collagen and gelatine have been derived has passed ante-mortem and post-mortem inspections conducted by an official veterinarian at a government approved slaughter establishment;
 - 1.3 Collagen and gelatine were not manufactured by using the brain, skull, eyes, spinal cord, vertebral column of cattle of 30 months of age and older, and the tonsils and distal ileum of cattle of all ages;

- 1.4 Bones of cattle have been subjected to a process which includes all of the following steps:
- i) degreasing,
 - ii) acid demineralisation,
 - iii) acid or alkaline treatment,
 - iv) filtration,
 - v) sterilisation at $\geq 138^{\circ}\text{C}$ for a minimum of 4 seconds,
- or to an equivalent or better process in terms of the destruction of infectious pathogens (such as high pressure heating);
- 2 For collagen and gelatine derived from hide and skin of cattle from countries with a reported case of BSE⁽¹⁾⁽²⁾
- 2.1 Collagen and gelatine have been manufactured in such a manner that prevents contamination with pathogens of infectious animal diseases;
 - 2.2 The animals from which collagen and gelatine have been derived, have passed ante-mortem and post-mortem inspections conducted by an official veterinarian at a government approved slaughter establishment;
- 3 For collagen and gelatine that are not derived from the items/materials mentioned in health attestation no. 1 and no. 2⁽²⁾:
- Collagen and gelatine have been manufactured in such a manner that prevents contamination by any pathogens of infectious animal diseases.
