THIS IS TO CERTIFY THAT: -

- 1) THE STRAW AND FORAGE HAVE BEEN PRODUCED AND STORED WITHIN THE 50 KM RADIUS AREA OF WHICH HAVE BEEN FREE FROM FOOT AND MOUTH DISEASES FOR AT LEAST FOR THE LAST TWO YEARS, RINDER PEST AND AFRICAN SWINE FEVER FOR AT LEAST FOR THE LAST THREE YEARS.
- 2) STRAW AND FORAGE FOR EXPORT TO REPUBLIC OF KOREA HAVE BEEN ORIGINALLY DERIVED FROM PAKISTAN.
- 3) STRAW AND FORAGE IS CLEAN AND HAVE NOT BEEN FOUND TAINTED OR CONTAMINATED WITH CLOVEN HOOFED ANIMALS AND THEIR EXCRETION, SECRETION AND OTHERS IN THE PROCESS OF PRODUCTION, PACKING AND STORAGE.
